

3 DOCUMENTS REQUIRED WITH ALL SHIPMENTS

3.1.1 BILL OF LADING (B/L) / AIRWAY BILL (AWB)

The B/L and/or AWB should show:

- B/L, AWB number
- The exporter's name (consignor)
- Port of loading (POL)
- On-Board date
- The consignee's name (Importer)
- Port of discharge (POD)
- Total: gross weight, volume, number of packages
- Vessel name (sea/ocean freight)
- Voyage number (sea/ocean freight) / flight number (air freight)
- Container number (sea/ocean freight)
- Freight type (collect or prepaid)
- Special handling instructions (if any). Ex: shipping temperature

3.1.2 COMMERCIAL INVOICE

Shipper must provide original commercial invoice (should be in English) along with the shipment and it must clearly show:

- Invoice number & Date
- Harmonized Tariff Schedule Code (HTS Code) next to each product
- Reference & Description of each product
- Quantity & Pricing Unit (Pc, Doz., Pack, Case, Kilogram, Liter, Kit, Set, Pair, Bottle, Gallon, Etc.)
- Unit price (One Lot / Lump sum Price is not acceptable by customs)
- Total price for each line item
- Total invoice value in numbers and letters

- Invoicing Currency
- Shipping terms (incoterm: (EXWORKS / CIF / CFR / DAP / DDP etc.)
- Country of Origin beside each SKU
- Contract reference (if applicable)
- Purchase order no.
- Names & addresses of the **Consignee** (importer) and the **Consignor** (shipper / exporter)
- Total number of packages, total net and gross weights
- L/C no. if available
- Shippers **STAMP & SIGNATURE IN BLUE INK**

Note: On the invoice, the following phrases shall not be used.

- a) Value for customs purposes only
- b) Free of charge

3.1.3 PACKING LIST

Shipper must provide original packing list along with the shipment and it must clearly show:

- Invoice number & date
- Item no., description, quantity, and unit (Pc, Doz., Pack, Case, Kilogram, Liter, Kit, Set, Pair, Bottle, Gallon, Etc...)
- Beside each product: package number(s), package dimensions (volume), and package net & gross weights.
- Total number of packages, total net & gross weights, and total volume (in CBM).
- Names & addresses of the **Consignee** (importer) and the **Consignor** (shipper / exporter).

3.1.4 CERTIFICATE OF ORIGIN (COO)

Shipper must provide original certificate of origin along with the shipment and must show:

- The country of origin of the shipped products issued by respective CHAMBER OF COMMERCE
- The invoice number / P/O number
- L/C no. if available
- Gross weight of the shipped cargo and total no. of packages
- Names & addresses of the **Consignee** (importer) and the **Consignor** (shipper / exporter)

The COO must be issued or at least stamped from the Chamber of Commerce or any other concerned authority.

The certificate of origin is required with all;

- **Marine (ocean / sea) freight shipments**
- **Airfreight shipments arriving at any airports apart from Abu Dhabi (e.g. Dubai, Sharjah etc.) in UAE.**

3.1.5 MATERIAL SAFETY DATA SHEET (MSDS)

- The MSDS shall show the detailed material composition of the product with workplace safety instructions
- Material Safety Data Sheet to accompany with all the DG & Non Hazardous Chemicals shipments

Other documents that are required with special type of products such as hazardous material:

3.1.6 TECHNICAL DATA SHEET (TDC)

- The TDC is a document summarizing the performance and confirming the technical characteristics of a product.
- Usually required with chemical and chemical compounds shipments.

3.1.7 DANGEROUS GOODS DECLARATION

- The shipper's written declaration in specialized forms is **MANDATORY** in the shipment of dangerous goods (hazardous materials) under the international regulations. The forwarder could provide the forms (Sample Forms) issued by the supplier or their representative.
- The shipper must certify that the contents of the consignment are fully and accurately described by proper shipping name and are classified, packed, marked and labeled, and are in all respects in the proper condition for transport according to the applicable international regulations. The description of the goods must be in technical (generic) names, not in brand (trade) names.

3.1.8 DANGEROUS GOODS NOTE (SEA/OCEAN & LAND FREIGHT)

The Dangerous Goods Note is a dangerous goods declaration, shipping note, and container/vehicle packing certificate. It is required in sea/Ocean & land freight.

It must clearly show:

- Names & addresses of the **Consignee** (importer) and the **Consignor** (shipper / exporter)
- Vessel Name
- Port of Loading (POL)
- Port of Discharge (POD)
- Total number and Kind of Packages
- Product reference and description
- IMCO Class (IMDG classification code)
- UN Number
- Flashpoint in degrees Celsius
- Total net & gross weights, and total volume (in CBM)
- Container/vehicle number, type, size and seal number
- Additional handling information

3.1.9 REACH COMPLIANCE REQUIREMENT

For all materials categorized as dangerous goods (within the meaning of EC Regulation 1907/2006, Article 3) the supplier shall notify Strata immediately in written form if any changes occur to the item using a material safety data sheet according to applicable EC Regulations (EC Regulation 1907/2006) and a technical data sheet. In addition, for goods which have been declared as products (within the meaning of EC Regulation 1907/2006, Article 3), the supplier shall notify Strata immediately in writing if any contained substances are listed on the REACH Candidate List.

3.1.10 IATA SHIPPER'S DECLARATION

The IATA (International Air Transport Association) Shipper's Declaration is a dangerous goods declaration required in airfreight shipments.

It must clearly show:

- Names & addresses of the **Consignee** (importer) and the **Consignor** (shipper / exporter)
- Vessel Name
- Port of Loading (POL)
- Port of Discharge (POD)
- Total number and Kind of Packages
- Product reference and description
- IMDG classification code
- UN Number
- Flashpoint in degrees Celsius
- Total net & gross weights, and total volume (in CBM)
- Container/vehicle number, type, size and seal number
- Additional handling information

3.1.11 CONFORMITY CERTIFICATES

The supplier shall provide a Certificate of Conformity (CoC) with each delivery of product/material unless otherwise specified on the purchase order.

In case a test report is required per the applicable purchase order, the supplier shall provide a Test Report in accordance with the applicable specification along with CoC with each delivery of product/material unless otherwise specified in the applicable purchase order or specification. For suppliers, who are acting, as a distributor for the ordered product/materials, both the manufacturer's CoC and the distributor's CoC are mandatory.

Any CoC shall have as a Minimum Content:

- Document unique serial number.
- Supplier's name, address and telephone number.
- Delivery address
- STRATA purchase order number.
- Description of goods supplied, identified by same part number / material buying standard as referenced on the STRATA purchase order.
- Serial / batch / lot / heat / cast numbers - as applicable to provide traceability.
- Quantity and date of dispatch.
- Shelf life details – if applicable to product/material delivered
- Statement confirming compliance with Strata purchase order requirements.

Typical wording is:

"Certified that the supplies detailed have been manufactured / inspected / tested and unless otherwise stated, conform in all respects to the relevant specifications, drawings and purchase order requirements".

- Signature of person authorized to release products to customer.

3.1.12 OTHER CERTIFICATES

Any other additional certificates (if required) maybe requested from suppliers by Strata based on the product type.
